ACCESS TO CORRECTIONS FACILITIES

Access to adult corrections facilities shall be at the sole discretion of the Sheriff's Office Corrections personnel.

Entry into a corrections facility may place you in danger. Your personal safety is not guaranteed. You may be exposed to offensive language or behavior.

All persons and property entering corrections facilities are subject to search.

You may not bring the following items into corrections facilities:

- Firearms, ammunition, knives, explosives, combustibles, or weapons of any kind.
- Alcohol, drugs, or tobacco.
- Cameras, cellular phones, laptops, palm pilots, or electronic devices, without the express permission of Corrections personnel.

Issuance of access or identification card does not mean that you may access all sections of a facility, enter without an escort, or use the identification card for any purpose other than identifying yourself at corrections facilities. You must display the visitor badge or your jail identification at all times while inside corrections facilities. Corrections personnel may ask you to explain your activities or level of access inside corrections facilities at any time. You must reapply when your access card expires, or your status with your host organization changes. Lost or stolen access cards must be reported to the Main Jail Watch Commander immediately.

Access to facilities and contact with inmates is permitted for official business only. Private practice by professionals for purposes other than those stated on the application is prohibited.

You may not wear clothing that is revealing, offensive or distracting.

You may not exchange property of any kind, including money, food or beverage, with inmates without the express permission of Corrections personnel. If you escort inmates off-site you may not purchase any items for them or on their behalf, make any unauthorized stops, or allow them to communicate with others in person, by phone, or by other means.

You may not have physical contact with inmates other than a handshake.

Any misconduct or violation of corrections facility rules, or failure to comply with the directions of Corrections personnel, shall result in your immediate removal from corrections facilities, denial of future access, and/or arrest and prosecution.
