- * 1. 7TH Ave and Brommer St road closure barricades preventing southbound traffic on 7th Ave, with an officer directing traffic eastbound onto Brommer St.
- * 2. 7th Ave and Capitola Rd warning sign indicating "Road Closed Ahead" (at 7th Ave and Brommer St.)
- * 3. 7th Ave and Eaton St road closure barricades preventing southbound traffic on 7th Ave, with an officer directing traffic northbound onto 7th Ave. Eaton St. @ 7th Ave. eastbound traffic closed.
- * 4. Eaton St and Lake Ave -road closure barricades preventing southbound traffic on Lake Ave, with an officer directing traffic eastbound towards 7th Ave.

- * 13. Spreckles Dr and Seacliff Dr officer directing traffic exiting area toward Highway 1, between 10 PM and midnight. Road closed to traffic, with detour sign directing back to Soquel Dr. / Hwy1.
